
PROCUREMENT OF PHILIPPINE RED CROSS COTBEDS IN RESPONSE TO MEASLES OUTBREAK OPERATIONS

Send copy of the bank deposit slip thru email immediately upon payment to the bank. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
- Bids and eligibility requirements must be delivered to the address below on or before **February 12, 2020** at **3:00PM**. All Bids must be accompanied by a Bid security in the form indicated in the bid documents. Late Bids shall not be accepted.

6. All bidders interested to participate should undergo PRC accreditation processes by applying with necessary documents requested and fees as required by PRC. No bidders should be allowed to participate without being accredited. Attached are Accreditation Form and Accreditation requirements.

The PRC reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders. It likewise assumes no responsibility whatsoever to compensate or indemnify the prospective bidders for any expenses incurred in the processing of their eligibility to bid and/or in the preparation of the bid.
