- The PRC BAC will be holding a **pre-bidding** conference on **04 December 2024**, 2:00pm at the PRC Tower, 9f Big Meeting Room.
- Bids and eligibility requirements must be delivered to the address below on or before **13 December 2024, 11:00am**. All Bids must be accompanied by a **Security Bid** in the form indicated in the bid documents. Late Bids shall not be accepted.
- All bidders interested in participating should undergo the PRC accreditation process by submitting the necessary documents and fees as required by the PRC. No bidders are allowed to participate unless accredited. Attached are the accreditation form and requirements.
- The PRC reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids any time prior to contract award, without incurring any liability to the affected bidder/s.
