

4. The PRC will be held a pre-bidding conference on **January 14, 2026** at **2:00pm** at the PRC National Headquarters located at the 37 EDSA cor. Boni Ave., Mandaluyong City
5. Bids and eligibility requirements must be delivered to the address below on or before **January 22, 2026, 11:00am**. All Bids must be accompanied by a **Security Bid** in the form indicated in the bid documents. Late Bids shall not be accepted.
6. All bidders interested in participating should undergo the PRC accreditation process by submitting the necessary documents and fees as required by the PRC. No bidders are allowed to participate unless accredited. Attached are the accreditation form and requirements.
