5. The BAC will hold a pre-bidding conference on **January 26, 2026, 2:00pm** followed by an inspection after the pre-bidding conference at the PRC Agusan Del Sur Chapter Govt. Center, Patin-ay, Prosperidad Agusan del Sur.
6. Bids and eligibility requirements must be delivered to the address below on or **before February 2, 2026; 11:00am**. All bids must be accompanied by a **Security Bid** in the form indicated in the bid documents. Late Bids shall not be accepted.
7. All bidders interested to participate should undergo PRC accreditation processes by applying with necessary documents requested and fees as required by PRC. No bidders should be allowed to participate without being accredited. Attached are the accreditation form and accreditation requirements.

The PRC reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids any time prior to contract award, without thereby incurring any liability to the affected bidder/s.
